Attorney Michalak – States the town at its annual reorganizational meeting should also review and adopt Villenova's rules and regulations for public meetings. After a brief discussion, upon recommendation, the board does hereby make the following motion:

***A MOTION was made by Sarah LoManto, seconded by Nathan Palmer NOTICE IS HEREBY GIVEN: The Town Board of the Town of Villenova does hereby adopt, ratify, amend, confirm and continue its policy regarding public meeting rules and regulations: THEREFORE according to Town Law Section 63 the rules and regulations for public meeting and public hearings it will read as follows:

TOWN OF VILLENOVA RULES and REGULATIONS for PUBLIC MEETINGS and PUBLIC HEARINGS Town Law 130(1)

- 1. Time allotted for public participation (three) 3 minutes.
- 2. Person or persons desiring to speak must sign a sheet upon entering.
- 3. Each speaker states his/her name and the subject he/she will be addressing.
- 4. Comments by speakers must be addressed to the town board. Attendees may not address the board until recognized by the Town Supervisor.
- 5. Discussion between speakers and attendees of the public meeting or hearing is prohibited. A speaker may not disagree with or support prior speakers in comments directed to the board.
- 6. Comments must relate to the purpose of the hearing or legitimate town business at the board meeting.
- 7. Speakers must present their remarks in a courteous manner and my not make personal comments about public officials, town officials, or others.
- 8. Placards, banners, signs and the distribution of flyers are not permitted in the meeting room.
- 9. A person who disregards the directives of the Supervisor in enforcing the rules, disturbs the peace at a

meeting or hearing, makes impertinent or slanderous remarks or generally conducts himself/herself in a boisterous or inappropriate manner while addressing the town board will be barred from further participation and forfeit any balance of time remaining for his/her comments.

- 10. After a final warning, if a speaker refuses to step down, the Town Supervisor shall request a police or peace officer to remove the individual from the meeting room. The authority for the Supervisor to do this is found in section 240.40 of the Penal Law; providing that a person is guilty of disorderly conduct when, with intent to cause public inconvenience, annoyance, or alarm or recklessly creating a risk thereof;
 - 1) He/she makes unreasonable noise or
 - 2) He/she in a public place uses abusive or obscene language or makes an obscene gesture or
 - 3) Without lawful authority, he/she disturbs any lawful assembly or meeting of person or
 - 4) He/she creates a hazardous or physically offensive condition by any act which serves no legitimate purpose.

Disorderly conduct is a criminal offense constituting a violation.
